# What is SHARP Literacy, Inc.?

SHARP Literacy is a unique program that promotes literacy through the power of art. SHARP is an acronym for **Student Historical Art Resource Program**. Formerly known as Creative SHARP Presentations, Inc., the organization increased the literacy skills of second through fifth grade students and their teachers in 30 Milwaukee area schools in 2006-2007 by 50-80%.

Highlights of the year included:

• 54 attendees participated in a twoday Teacher Summer Workshop

- 88 educators attended the Teacher Inservice at the Milwaukee Art Museum
- 5,200 Student Workbooks and Teacher Guides were distributed
- 560 presentations were made in SHARP schools
- 5,784 books were distributed for the A Book in Every Child's Hands initiative
- 306 creative writing books were distributed to classrooms
- 4,553 children, teachers, and parents/guardians took part in SHARP Literacy tours of the Milwaukee Art Museum
- 87% responded to our Year-end Writing Challenge
- 2,067 attended the Family Achievement Recognition events

# **The Eight Building Blocks of SHARP** 2006-2007 Accomplishments

Twelve SHARP teachers enrolled in "The SHARP Eight Building Blocks" course at Cardinal Stritch University, where the class is offered as a 3-credit graduate level experience. The class explores SHARP's innovative concepts and teaching strategies and is offered at a special reduced tuition price to encourage and support SHARP teachers.

## 2006 Teacher Summer Workshop

Our two-day Teacher Summer Workshop, held at the Woman's Club of Wisconsin on June 20 and 21, 2006, was attended by 54 educators. The following ten schools participated: Blessed Sacrament School, The Business and Economics Academy of Milwaukee, Dr. Benjamin Carson Academy, Emmaus Lutheran School, Forest Home Avenue School, Neeskara Elementary School, St. Anthony School of Milwaukee, Steffen Middle School and Urban Day 12th and 24th Street Schools.

• Full fourth grade lesson plans were reviewed and discussed.

The 2006 Teacher Summer Workshop was generously underwritten in part by the Greater Milwaukee Foundation's Annette J. Roberts and Joan R. Robertson Fund for World Peace, World Law, and Peace Education.

## **2006 Teacher In-Service**

On September 26, 2006, 88 educators from 28 SHARP schools attended the Teacher In-Service held at the Milwaukee Art Museum.

To complete the day, teachers received docent-led tours of the Milwaukee Art Museum specially designed for SHARP and specifically tailored to each grade level during which docents provided information about artwork relevant to the vocabulary and required curriculum for each grade level.

The 2006 Teacher In-Service was generously underwritten in part by the Helen Bader Foundation.

### Student Workbooks and **Teacher Guides**

All workbook pages meet the Milwaukee Targets and conform to Wisconsin Model Academic Standards for required curriculum in Language Arts, Science, Social Studies, and auxiliary standards such as Information and Technology

Literacy, and Art and Design Education.

## **In-School Presentations**

Approximately 560 presentations were given in all 28 SHARP schools. First semester presentations prepared students for their upcoming



- The United Nations Classroom Charter Project was developed for each grade.
- The release of <u>All Around Milwaukee</u> was discussed.
- Student Workbooks and Teacher Guides were updated with the help of Linda Sonnenberg and Joan LoPresti, leaders in the field of creative writing and reading instruction.
- Three exciting 2006-2007 enrichment projects were introduced.



The day began with a special sneak preview of the latest We Love to Learn book, <u>All</u> <u>Around</u> <u>Milwaukee</u>. SHARP Board Member Patricia A. Ellis, Ed.D., Vice President of

University Outreach at Cardinal Stritch University, informed teachers of the new SHARP graduate course offered at Cardinal Stritch University. Joan LoPresti and Linda Sonnenberg shared their successful "Reading and Writing Strategies in Non-Fiction."

In the afternoon, teachers divided into breakout sessions for each grade level.

At the beginning of the 2006-2007 school year, 4,900 grade level specific workbooks were printed and distributed along with approximately 300 corresponding teacher guides.





Milwaukee Art Museum curriculum tour by viewing slides and discussing how the artwork relates to the required curriculum for their grade level. Oral practice and flashcards were used to reinforce vocabulary words related to the required curriculum and art appreciation.

Second semester presentations explored the subject matter in greater detail with a new selection of artwork and prepared students to demonstrate what they learned using their new vocabulary to complete a creative writing piece for the Year-End Writing Challenge.

### **SHARP Literacy Tours** at the Milwaukee Art Museum

with a matching pen to write down their thoughts, stories and poems.


To mark the accomplishments of their first year in SHARP, the Second Grade Family Achievement Recognition Event was held at Serb Hall. Students each


